First I direct all my just debts and funeral expenses to be fully paid and satisfied  
 by my Executor hereinafter named as soon as conveniently may be after my decease

Second I do hereby order and direct also authorize and empower my Executor hereinafter  
 named to sell at a private sale as soon as conveniently can be done after my decease  
 my house and lot of ground situate in East Freedom Blair County Penna for the best  
 price that can be gotten for the same and by proper Deed to be duly executed acknowledged  
 and perfected to grant convey and assure the same to the purchaser thereof.

Third I do hereby authorize and empower my said Executor hereinafter named to sell and  
 dispose of all my personal property (Except my Sewing Machine) at public sale for the  
 best price that can be gotten for the same as soon as conveniently can be after my decease

Fourth Whereas by an instrument of writing bearing date the 6<sup>th</sup> day of January A.D. 1876  
 signed by myself and J. W. Cleaver Past. Wm. M. Bloom Secy. and W. C. Lyngner Treasurer  
 of the Board of Trustees of Martinsburg M. E. Church I expressed a desire to sell to the Trustees  
 and their successors in Office the House and lot of ground which I now occupy situate  
 in Martinsburg Penna on the east side of Market Street extending back 122 feet to lands  
 of James Clarke Heirs bounded on the North by land of the said James Clarke Heirs  
 and on the south by lot of the M. E. Parsonage for the sum of \$150<sup>00</sup>. I do now hereby au-  
 thorize and empower my Executor hereinafter named by proper Deed to be duly signed  
 executed acknowledged and perfected, to grant convey and assure the said house & lot of ground  
 to the said Board of Trustees and their successors in office and take their judgment note for the  
 sum of \$150<sup>00</sup> payable one year after date the same to bear Interest from date until paid

Fifth I give and bequeath to my son Henry Stiffler the sum of Five Dollars

Sixth I give and bequeath to my son William Stiffler my Sewing Machine

Seventh When the whole of my Estate shall be converted into money as aforesaid and all my debts  
 funeral expenses and the bequest to my Henry Stiffler has been fully paid the balance that may  
 then remain, I will and direct that the same shall be divided into three equal parts or shares  
 and disposed of as follows to wit one full equal third part or share thereof I give devise & bequeath  
 unto my daughter Mary intermarried with Miles Lyngmaster. One other of the said full equal  
 third parts or shares thereof I give devise and bequeath unto my son William Stiffler and

The remaining one full equal third part or share thereof I give devise and bequeath unto my said Executor hereinafter named in trust, that he do and shall put and place the same out at interest in the hands of the Trustees of the Martinsburg M. E. Church and their successors in office and pay over the interest thereof from time to time when and as the same shall be got in and received unto my daughter Nettie Jane intermarried with Lewis Guyer so nevertheless that the same shall be for her sole and separate use, not to be in any way or manner whatever liable to the contracts debts or engagements of any husband which she may have or take, and not to be in any way or manner whatever subject to the control or interference of such husband during her natural life, And in no case my said daughter Nettie Jane should be left a widow by the death of her present husband Lewis Guyer, then and immediately after the death of the said Lewis Guyer I give devise and bequeath the principal of the said one third part or share aforesaid to my said daughter Nettie Jane for her sole and separate use, but in case my daughter Nettie Jane shall die before her present husband Lewis Guyer then from and immediately after the death of my said daughter Nettie Jane, I give devise and bequeath the principal of the said one third part or share aforesaid unto my Executor hereinafter named in trust that he leave the same in the hands of the Trustees of Martinsburg M. E. Church and their successors in office to remain on interest until every the child or children which she may my said daughter Nettie Jane may leave until such child or children shall severally attain the lawful age of twenty one years, and when and as soon as they arrive at the age aforesaid then to pay over an equal share of the principal thereof together with any accumulation of interest thereon to each one upon their attaining the age of twenty one years, And in case of the decease of my said daughter Nettie Jane without leaving lawful issue who shall attain the age of twenty one years, then, and in such case I give devise and bequeath the said equal third part or share herebefore given devised and bequeathed to my daughter Nettie Jane and all interest accrued thereon unto my said daughter Mary intermarried with Miles Lingenfelter and my said son William Huffer share and share alike

Lastly I nominate constitute and appoint my son-in-law Miles Lingenfelter to be the Executor of this my last Will and Testament, In Witness whereof I have hereunto set my hand and seal the 5th day of October A. D. 1878
