CHAPTER 110—REVISED STATUTES.

SECTION 8. It shall be the duty of every clergyman, justice of the peace, clerk, and any other person, or society, by or before whom any marriage may hereafter be solemnized or contracted, to make out at once a record of the same, in a book to be kept for that purpose, and within thirty days after such marriage to return the same in the form of a certificate, duly signed by the person so certifying, to the register of the county in which said marriage shall be solemnized or contracted; which said record or certificate shall set forth, so far as the same can be ascertained, the full name of the husband, his occupation, and the name of his place of birth and residence; the full name of the wife previous to the said marriage; the name of the parents of said husband, and of the parents of said wife; also the color of the parties, and the time, place where and ceremony by which such marriage was contracted, and if pronounced by any clergyman or other person, as aforesaid, the place of residence of such person.

SECTION 16. Any clergyman, justice of the peace, physician, or other person, who shall neglect to comply with the provisions of sections 2, 3, 4 and 12, of this chapter, shall forfeit for such neglect, a sum not less than fifty nor more than one hundred dollars.
