ORDER ALLOWING TEMPORARY
INJUNCTION

It satisfactorily appearing to me from the affidavit of Bessie Nephews that the Hon. Fred W. Messmore, Judge of the District Court of the 18th Judicial District of the State of Nebraska, and the Judges of the Supreme Court of the State of Nebraska are now absent from Jefferson County, and this cause coming on for hearing upon the petition of plaintiff, positively verified, the same was submitted to me, and on consideration whereof it is ordered that an Injunction be granted herein, enjoining the defendant, Alex Nephews, from going within the plaintiff's home, or upon the premises adjacent thereto, ^{or from remaining in or about plaintiff's home,} /from abusing and misusing the plaintiff, from assaulting or threatening to kill the plaintiff, or from in any manner interfering with plaintiff's freedom in and about said home, or the premises adjacent thereto; from injuring, damaging, removing or destroying any of the household goods, or from in any manner interfering with plaintiff, or her ~~xxx~~ property, or such property as is claimed by her, during the pendency of this action; this order to take effect upon the plaintiff giving notice to the defendant, and executing and delivering to the Clerk of the District Court of said County an undertaking to the defendant in the sum of One Hundred Dollars with approved sureties, conditioned as required by law.

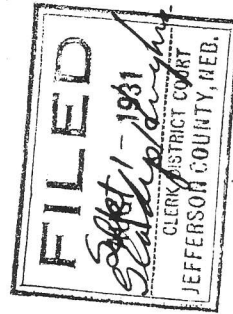

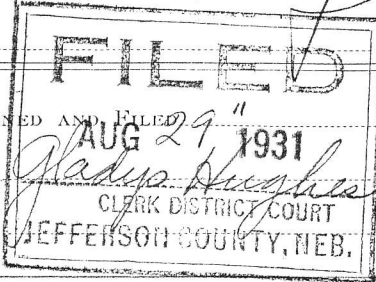
